
What is the City of Sault Ste. Marie's Pre-Authorized Tax Payment Plan For Arrears?

Quite simply - it's the easy way to pay your taxes. This voluntary plan offers you a convenient, time-saving way to have tax payments automatically deducted from your bank account.

Property owners, who are in tax arrears, have an option for worry-free tax payments. There are three (6) different payment dates from which to choose.



Payments are withdrawn automatically from your bank account on the **first** (1st) day of each month, the **fifteenth** (15th) day of each month and the **last business day** of the month. If any of these withdrawal dates falls on a Saturday, Sunday or holiday, withdrawal will be on the next business day.

Also available are exact date withdrawals once a month or biweekly or weekly start date.

Administration

What if I Change My Mind or Switch Banks?

There are no administration fees for this program. However, the interest and penalty by-law will still apply for any past due balances.

If you wish to continue with the preauthorized plan once the tax arrears have been paid in full, you may apply for either of the following two pre-authorized payment plans:

- ◆ Due Date Tax Payment Plan
- Monthly (January to October) Tax Payment Plan

If you move, or just want to cancel, simply notify the Finance Department — Tax & Licence Division of the change (in writing) 20 days prior to the next payment date.

If you change your bank account, a current cheque is required for our records.

What if I Miss A Payment?

Your plan will be terminated if two installments are not honoured in a calendar year. The City will charge a fee for any payment which cannot clear your account.
