

THE CORPORATION OF THE CITY OF SAULT STE. MARIE

BY-LAW 2003-140

**REGULATIONS:** (E.3.4.6) being a by-law to establish fees for certain waste management services.

Whereas notice of this by-law coming before Council was given in the June 26, 2003 issue of the Sault Star.

**THE COUNCIL** of the Corporation of the City of Sault Ste. Marie, pursuant to Section 391 of the *Municipal Act* 2001, S.O. 2001, c. 25 and amendments thereto and to Section 4 of O. Reg. 244/02, **ENACTS** as follows:

1. CURBSIDE LIMITS

- (a) Effective January 1, 2004, a maximum number of four (4) garbage bags or four (4) containers per household per week shall be collected at curbside.
- (b) Effective May 1, 2004, a maximum number of three (3) untagged garbage bags or three (3) untagged containers per household per week shall be collected at curbside.
- (c) Effective January 1, 2005, a maximum number of two (2) untagged garage bags or two (2) untagged containers per household per week shall be collected at curbside.

2. TAGS FOR EXCESS

- (a) Effective January 1, 2004, any bags or containers in excess of the limits as set out in this by-law must bear a municipal identification tag.
- (b) Municipal identification tags will be available from January 1, 2004 at a fee of \$2.00 per tag.
- (c) Any bags or containers in excess of the limits as set out in this by-law without the municipal identification tag will not be collected.

3. LANDFILL GATE FEE

- (a) Effective September 1, 2003, the fees to gain access at the entrance gate at the municipal landfill, 402 fifth Line East, shall be \$4.00 per visit for waste weighing 500 kg. or less. The landfill tipping fee shall apply to all waste in excess of 500 kg.
- (b) Effective March 1, 2012, the fee to gain access at the entrance gate at the municipal landfill, 402 Fifth Line East shall be \$10.00 per visit. [Amended by By-law 2012-31]

4. LANDFILL TIPPING FEE

- (a) Effective September 1, 2003, the tipping fee at the municipal landfill shall be \$40.00 per tonne.
- (b) Effective January 1, 2005, the tipping fee at the municipal landfill shall be \$55.00 per tonne.
- (c) Effective March 1, 2011, the tipping fee at the municipal landfill shall be \$70.00 per tonne. [Amended by By-law 2011-43]

5. EFFECTIVE DATE

This by-law takes effect on the day of its final passing.
