Further that Council directs staff to utilize internal debt to fund the total adjusted unfunded capital amount of \$2,174,900 as follows:

- increase capital from current by \$200,000 to service internal debt in 2020
- apply the additional PUC dividend of \$400,000 declared in 2019 to the 2020 internal debt

• fund the remaining balance of 2020 internal debt servicing through the levy, after the 2019 surplus allocation, equally each year from 2021 through 2024.
