Request for Tender Roberta Bondar Marina Boardwalk Extension (File # 2022CDE-CS-03-T)

Tenders will be received by the City Clerk at 99 Foster Drive, 4th Floor, Civic Centre, Sault Ste. Marie, Attention to: City Clerk, until **3:00 p.m. local time on Friday, July 15, 2022** for the construction of the works described below.

The work generally consists of the construction of a new boardwalk extension along the east side of the Roberta Bondar Marina. The new boardwalk will be elevated and supported on new steel support beams as well as new steel piles driven into the existing bank.

Tender documents may be studied, but not removed, at the Sault Ste. Marie Construction Association, 117 White Oak Drive East, Sault Ste. Marie, Ontario and at the office of the Consulting Engineer.

Complete tender documents, including tender forms and envelopes, may be obtained by general contractors commencing, **Friday, June 24, 2022** from the office of the Consulting Engineer, WSP, 185 East Street, Sault Ste. Marie, upon payment of a \$100.00 refundable document deposit payable to the Corporation of the City of Sault Ste. Marie for each set of contract documents. **Only Contractors who submit a bona fide tender** will have this deposit refunded if the documents are returned in good condition within fifteen (15) days following the tender closing date.

A mandatory site visit will be convened on Tuesday, July 5th, 2022 at 2:00 p.m, in parking lot adjacent to the project site (Montana's).

Tenders must be accompanied with a tender deposit in the form of a certified cheque, money order, bid bond or bank draft in the amount of **\$60,000.00** payable to the Corporation of the City of Sault Ste. Marie. The tender deposit and Agreement to Bond shall be delivered to the City in an envelope marked to the City Clerk with the tender package. The successful bidder will be required to provide a 100% Performance Bond and a 50% Labour and Material Payment Bond upon execution of the contract.

A public opening of tender will be held in the Biggings Room, Civic Centre, 99 Foster Drive at 3:15 p.m., local time Friday, July 15, 2022, during which time viewing is available at <https://www.youtube.com/SaultstемarieCa>.

Tenders are subject to a formal contract being prepared and executed. The Corporation of the City of Sault Ste. Marie reserves the right to reject any or all tenders and the lowest or any tender will not necessarily be accepted.
