#### 2. Review Terms of Reference – Attached

S. Zuppa noted that this is a Committee of Council, which means it is subject to Procedural By-law 2013-100 – so we have to follow the procedures in that By-law. Most of this is covered in the Terms of Reference for the committee.

The purpose of the committee is to recognize exceptional community development projects by recommending one award winner per year to Council. Council ultimately approves that recommendation.

The term "Community Development" is broad. For a project to be eligible for the award, it should positively benefit the community in one or more of the following ways:

- Enhance the visual quality of the built environment
- Pursue sustainable development and protect the natural environment
- Promote equity and accessibility to a variety of people, income groups, and abilities
- Maximize employment and earning opportunities
- Facilitate heritage preservation
