Economic Development Program application for Rural Community Immigration Pilot (RCIP)

Legal name of business/organization The Corporation of the City of Sault Ste. Marie **Names of Officers, Directors & Principals** Travis Anderson

The Corporation of the City of Sault Ste. Marie provides municipal services through the operation of various departments. The City's mission is to promote, encourage, and lead economic and social growth within our community through the effective provision of municipal services and the development of community partnerships. This Rural Community Immigration Pilot (RCIP) will be led by Travis Anderson the Director of Tourism and Community Development,

Through RCIP we intend to attract and recommend over 1500 skilled professionals, additional dependents in and outside of Canada, and their families to Sault Ste. Marie. Through the process, we intend to assist over 150 -200 companies in attracting and retaining skilled workers, by assisting them with their near and long-term growth plans. In some cases, particularly in the aerospace sector, if we can assist employers in recruiting key sectors such as manufacturing, healthcare, and skilled trades, we can facilitate the growth of the companies allowing them to add additional assembly or product lines, thereby increasing the overall employment in the company.

This is critical to a northern community such as Sault Ste. Marie, with an aging workforce. The attraction and retention of a younger workforce will assist and add to the resilience and diversity of the community.

Key project outcomes could include:

Attracting and retaining newcomers to Northern Ontario

- 1500 jobs maintained for over five years (300/year).
- 150 new and existing local businesses assisted through information sessions and outreach activities.
- Maintaining ten partnerships with post-secondary and community service organizations locally, regionally, nationally, and internationally
- Developing and maintaining eleven strategic alliances with local and provincial cultural organizations
- Support the Sault Ste. Marie's physician recruitment team to hire Physicians and healthcare workers

Based on the criteria set out by Immigration Refugee and Citizenship Canada (IRCC), the City will conduct outreach events to share awareness of the program, it will also conduct several information sessions for employers and potential applicants locally, regionally, nationally and internationally.

Each application will first undergo a comprehensive assessment to ensure that all the information provided is accurate and that the application is eligible and meets the criteria for suitability. This meticulous review process is designed to maintain the highest standards of integrity and fairness.

Following the initial assessment, applications will be carefully processed to confirm that all necessary documentation and requirements have been fulfilled. Once the review and processing stages are complete, as this is an employer-led pilot the employers will be at the forefront of deciding who they



choose to assist through the program.

By looking at the strategic goals and priorities of the labource needed in Sault Ste. Marie The city will choose the applications after the employer has been designated. For those applications that receive approval, a formal letter of recommendation will be issued by the city. This letter serves as a significant endorsement, reflecting the city's support for the applicant. The letter of recommendation not only adds credibility to the application but also signals the city's commitment to fostering successful outcomes through collaboration with community stakeholders.

The City of Sault Ste. Marie is committed to the administration of the RCIP Program and has secured dedicated funding to support the program in the following ways:

FEDNOR funding \$1,025,000

The city is requesting **\$102,500** thousand from the EDF fund Project Cost

As a municipality, we could see continued population growth, increased consumer spending, expansion of community services and infrastructure, and renewed innovation and entrepreneurship:

- Increased Property values
- Upskilling of the workforce
- Strengthen local businesses on the community as a whole

Our plan to keep track of Key Performance Indicators, with quarterly and annual reporting.

Key indicators include:

- number of applicants processed
- number of businesses supported
- geographic location of applicants (i.e. what countries they are coming from).
- retention in the community.
- attendance at job fairs, information sessions, workshops, etc.

To track these indicators, we would use specific digital software, so that we can measure and compare data on a quarterly basis while utilizing spreadsheets to keep track of the demographics and countries where skilled professionals are coming from.

Furthermore, we would have regular touchpoints with employers to discuss the outcomes of the pilot, as well as confirmation of employee retention.

Annually we would summarize our findings and include details on program success, challenges, and areas for improvement. These reports would be shared with stakeholders, funders, and the community.
