

5.1 Parks Projects Updates

Downtown Plaza launch on November 16th was very well attended. Good comments from the public. Averaging 40-50 skaters per evening. Greyhound fan parties and viewing parties are ongoing. Syrian Kitchen is opening. Special Christmas markets. Please refer to city website for plaza schedule.

Twin Pad Arena is closing on final items.

The stairwell at GFL Memorial Gardens stair closure is 95% complete.

Pointe Des Chenes shelter is in the final stages in regard to receive grant funding. Accessibility will be improved with grant money, including accessible pathways, door actuators and ramps. A special chair allowing beach and water access will be available. Disc golf sets will be available and beach volleyball courts will be installed. Approximately 730 bus rides to the park were taken during the summer of 2023.

Manzo Park Splash Pad is wrapping up. The pad has been installed and groundwork completed. Some roadwork still needs to be done in spring. Change stalls and shade area to be installed in spring. Launch is expected in 2024 summer season.

Rosedale Park basketball court will be installed using additional funding from Kiwanis.
