

RE: International Mutual Aid Agreement

Purpose

The purpose of this report is to renew the International Mutual Aid Agreement between the City of Sault Ste. Marie Michigan and the City of Sault Ste. Marie Ontario for fire service emergency responses.

Background

A Mutual Aid Compact and By-law were approved on October 15, 1984, by both twin cities. The two countries are separated by the border but are joined by this agreement and the activities of fire suppression, rescue and emergency response. The agreement is activated when aid is required in the form of additional apparatus or staff for emergency service operations.

Analysis

Over the life span of the agreement there have been multiple responses to Sault Ste. Marie Michigan. Between 1998 and 2022 there were 7 responses, with the most recent being in June 2015. Typically, one apparatus staffed with Fire Crew has responded.

In the event either city requires assistance, this agreement will provide the necessary means to ensure an approved process is in place ahead of the emergency.

Financial Implications

Either municipality rendering aid pursuant to this agreement shall be reimbursed for loss or damage to any equipment.

Strategic Plan / Policy Impact / Climate Impact

Service Delivery - The International Mutual Aid Agreement will ensure that the City of Sault Ste. Marie Fire Service will continue to provide efficient and effective service to the community, resulting in excellent customer service.

Economic Growth Projects

- Algoma Steel Electric Arc Furnace
 - Over \$700MM Project
 - Proceeding on track for full implementation in 2029
 - First furnace scheduled online in 2024
- Downtown Plaza Project
 - Scheduled to open Fall 2023
 - Four season programming
 - Public stage, food, ice rink, retail, fountain, play area

Economic Growth Projects

- New Downtown Farmers Market
 - Relocating market into a new facility on Brock Street, adjacent to the Downtown Plaza
 - Officially opened this past weekend
- Queen Street Rejuvenation
 - Multi-year phased rejuvenation of the Downtown Area
 - Phase 1 starts 2024 with \$6M investment
- Industrial Land Sales
 - 31 Acres combined sold and conditionally sold in 2023
 - Aiding in job creation and tax base growth
 - Environmental assessment planned to develop access road into Wood Park Court Industrial Park – will open up an additional 60+ acres of developable land

Economic Growth Projects

- Strategic Plan
 - Developing new Economic Development Strategic Plan
 - Green/Cleantech/Industrial land focused
 - Cross border cooperation
 - Will align to new Corporate Strategic Plan
 - Tentative release Q1 2023
- Other Economic Growth
 - Station Mall \$60M Investment Announced
 - Retail Development on Great Northern Road (Princess Auto, Winners/ Home Sense)
 - Wellington Square Mall Revitalization, now called the Shoppes on Transcanada
 - New 107 unit apartment building under construction with Royal Canadian and Sal-Dan Developments
 - Strong focus on housing development from Federal and Provincial governments with new incentives that are expected to spur new construction
