Codes of Conduct, Changes to Visible Fees, and Fees Charged to Beverage Producers

Policy Update • March 27, 2023

AMO Calls for Legislation to Strengthen Municipal Codes of Conduct and Enforcement

At its meeting on March 24th, 2023, the AMO Board reaffirmed its recommendations to the Minister of Municipal Affairs and Housing to strengthen municipal Codes of Conduct and compliance. AMO has written to the <u>Minister</u> and to the <u>Premier</u> to request new legislation to enact the recommendations.

In 2021, AMO was asked to provide <u>recommendations</u> to the Minister to strengthen the application of municipal Codes of Conduct for elected officials. AMO supplied a number of strong recommendations to the Minister including:

- Updating municipal Codes of Conduct to account for workplace safety and harassment
- Creating a flexible administrative penalty regime that could be adapted to the local economic and financial circumstances of municipalities across Ontario
- Increasing training of municipal Integrity Commissioners to enhance consistency of investigations and recommendations across the province
- Allowing municipalities to apply to a member of the judiciary to remove a sitting member if recommended through the report of a municipal Integrity Commissioner

On March 24th, 2023, the Board also approved a further recommendation to prohibit a member removed through application to a judge from running for election in the term in which removed and the subsequent term of office.

AMO's Board believes that ethical behaviour and respectful civil discourse are fundamental to continued public faith in democracy. The Board further believes that the current tools available to municipal councils to ensure such ethical behaviour and respectful discourse are inadequate and do not meet public expectations. The Board has called on the government to release the results of its 2021 consultations and to work in partnership with AMO and municipal governments to legislate the recommended changes.

AMO has provided <u>sample resolution text</u> for councils that wish to lend their support to this call.

Requirement related to visible fees removed from all Resource Recovery and Circular Economy Act, 2016 Regulations

The Ontario government has amended the regulations for tires, batteries, electronics and hazardous and special products under the Resource Recovery and Circular Economy Act, 2016 (RRCEA) to remove promotion and education requirements related to visible resource recovery fees (RPRA's announcement). These changes were not consulted on, but we do understand that a number of business associations like the Retail Council of Canada have advocated for their removal.

The use of visible resource recovery or ecofees have been a concern for municipal governments since <u>issues related to their use in 2010</u> lead the government to dismantle a substantial proportion of the household hazardous waste stewardship program. As a result, the provincial government downloaded costs back to municipal governments.

Requirements on the use of visible fees have been in place since 2018 for tires and were added for batteries, electronics, and household hazardous waste products at the beginning of the year. The latest changes remove all consumer protection provisions and come just after concerns were raised by the Toronto Star about proposed <u>new visible fees on beverage containers</u>.

The Canadian Beverage Container Recycling Association's (CBCRA) fee structure to be implemented June 1, 2023

CBCRA has released its <u>plans to start charging fees</u> to beverage producers on June 1, 2023 (see table below). These fees will apply to all sealed and ready to drink beverage containers made from glass, paper or rigid plastic (e.g., pop, water, dairy, juice). CBCRA's communication materials are clear that whether or how the costs might be passed through are at the discretion of producers.

CBCRA expects to raise \$63 million in funding through these fees in 2023 and \$84 million in subsequent years. They project roughly half the costs will be spent on promotion and education and purchasing new public space recycling bins.

Municipal governments will want to be prepared to answer questions from residents if these costs are passed through directly to consumers, especially given the costs may be well before all municipal governments transition their blue box programs and well before any improvements to the system are seen.

Municipal Councils will need to consider how they may answer questions about any savings realized from no longer being required to fund blue box programs once transition is completed in your community.

The Beverage Association has noted they are working with the Retail Council of Canada on a promotion and education campaign for consumers. AMO will work to obtain greater information on this plan.

Canada's 2023 Budget, A Made in Canada Plan

Policy Update • March 30, 2023

Through its ongoing advocacy, AMO wanted to see progress in two key areas for the 2023 Budget:

Homelessness: As the only province in Canada where housing and homelessness is a shared municipal-provincial funding responsibility, AMO provided key recommendations for federal investment:

- increase Ontario's allotment under the National Housing Strategy and subsidy of the Canada-Ontario Housing Benefit;
- scale up key federal programs, including the Rapid Housing Initiative and Reaching Home;
 and
- accelerate the development and implementation of an Indigenous-led housing strategy.

Infrastructure: To support growth, adapt to climate change and ensure municipalities' ability to effectively manage existing assets by providing stable, predictable funding, AMO called on the federal government to:

- · expeditiously renew the next Canada Community Building Fund agreement; and
- renew investments under the Investing in Canada Infrastructure Program.
- yesterday, Canada's Minister of Finance introduced the <u>2023 Budget</u>, <u>A Made in Canada Plan</u> for a strong middle class, affordable economy and healthy future.

Homelessness

- AMO commends the Federal Government commitment of an additional \$4 billion, over seven years, starting in 2024-25, to implement a co-developed Urban, Rural, and Northern Indigenous Housing Strategy.
- While the Budget did not include new commitments to address homelessness, essential
 programs are being maintained. AMO will continue to highlight the need to expand the Rapid
 Housing Initiative and the Reaching Home program as important ways to address
 homelessness. AMO will be interested in future discussions with the Province of Ontario
 considering this announcement from the Federal Government.

Housing

• The federal government followed through on commitments for the \$4 billion Housing Accelerator Fund to 2026-27. It will provide incentive funding for municipal governments to fast track the creation of 100,000 new homes across Canada.

Infrastructure

• In 2022, the Government of Canada committed to accelerate the investments through the ten-year Investing in Canada Infrastructure Plan (ICIP) that begun in 2018. The 2023 Budget notes that by March 31, 2023 almost all remaining funds in ICIP will be committed. With ICIP fully committed in 2023, pressures for growth and adaptation to climate change, and Bill 23's limiting municipalities' use of development charges, we will continue to discuss with federal and provincial partners the need for a next generation municipal infrastructure program to support communities going forward.

Other Notable Investments

- \$144 million over five years, starting in 2023-24, to Health Canada for the Substance Use and Addictions Program to fund community-based supports, including safer supply, supervised consumption sites, and other evidence-based health interventions.
- Lays out the next steps in the government's plan to build Canada's clean economy by proposing significant investments to accelerate the supply and transmission of clean electricity.
- \$13 billion over five years and \$4.4 billion ongoing to implement the Canadian Dental Care Plan to provide dental coverage for uninsured Canadians with annual family incomes of less than \$90,000.
- An additional commitment of \$195.8 billion over ten years in health transfers to provinces and territories, including top-ups of at least 5% per year over the next 5 years.

Less Red Tape, Stronger Economy Act Introduced & Upcoming AMO Events

Policy Update • April 05, 2023

The Honourable Parm Gill, Minister for Red Tape Reduction, introduced the <u>Less Red Tape</u>, <u>Stronger Economy Act</u>, <u>2023</u>. The Bill contains several items of interest to municipal governments.

The Building Broadband Faster Act, 2021 (BBFA)

The Bill includes measures to support the efficient completion of broadband projects, including:

- clarification that Municipal Access Agreements (MAAs) to enable rights of way must be completed within a 10 to 15 day timeline; and
- clarifications regarding the collection of local utility infrastructure data.

The BBFA guidelines will also be updated with information on a new dispute resolution process; efforts to speed up the Ministry of Transportation's permit process; and cost sharing for use of electric infrastructure.

The Government is seeking feedback on proposed legislative, regulatory and guideline changes through the ERO.

MAAs with internet service providers are helpful tools to set service expectations, terms for access and responsibilities for permit requests, and cost recovery fees. AMO encourages any members that do not currently have MAAs in place to consider establishing one as soon as possible, leveraging the following resources:

- Sample MAA on CRTC's Agreements and Guidelines web page
- Federation of Canadian Municipalities (FCM)'s Rights of Way Handbook

- Sample MAAs provided by the <u>Town of Caledon</u> and the <u>Counties of Stormont</u>, <u>Glengarry</u> and Dundas and Prescott Russell
- The Town of Caledon's Council <u>memo</u> detailing changes to their rights of way access procedures and application form
- The District of Muskoka's <u>Regional Broadband Strategy</u> which includes efforts to harmonize agreements and procedures across municipalities to prepare for broadband builds

AMO and the Ministry of Infrastructure will reconvene the Technical Working Group on Broadband to support communication with municipalities and address implementation issues.

Other Less Red Tape, Stronger Economy Act, 2023 Highlights

Other notable highlights for municipalities include:

- Amendments to the Municipal Act to eliminate authority for municipal vehicle towing and storage licensing requirements. The provincial government has introduced provincial oversight of the vehicle towing and storage industry and will serve as the regulator
- Changes the Highway Traffic Act to prohibit overtaking snowplows travelling in staggered formation on multi-lane roads with speed limits 80 km/h and over. This amendment improves road safety for drivers and snowplow operators
- Any Planning Act submissions (official plans, development proposals, etc.) within 800M of provincial highways will be required to include pre-consultation with the MTO
- Measures to make it easier to transfer cannabis retail store and manager licenses on application to the LCBO
- Amendments to the Ontario Energy Board Act to exempt electricity and natural gas
 marketing pilots from having to obtain a license for a period of up to five years and a
 potential extension, which could more easily allow innovative pilot projects. The OEB Act is
 also amended to prohibit Administrative Monetary Penalties from being passed on to
 consumers.

Helping Homebuyers, Protecting Tenants Plan

Policy Update • April 06, 2023

Today the Government introduced its latest Housing Supply Action initiative, Helping Homebuyers, Protecting Tenants Plan and its complementary legislation, <u>Bill 97, Helping Homebuyers, Protecting Tenants Act, 2023</u>. In addition to tabling legislation, there are approximately 8 associated regulatory proposals open for consultation.

The plan proposes actions to:

1. Protecting tenants and building rentals

With a central focus on improving the rental housing space, AMO is pleased to see that Helping Homebuyers, Protecting Tenants Plan and associated legislation and regulatory proposals that recognizes the full continuum of housing and attempts to make life easier for renters. This work is consistent with to ongoing advocacy from AMO around improving landlord-tenant relations.

2. Helping homebuyers

The Government continues to look at a range of tools to help make homebuying more accessible, including regulatory amendments to help first time homebuyers save for a downpayment, freezing provincial housing development fees, exploring consumer protection opportunities for new home purchases, and continuing advocacy with the federal government.

3. Streamlined provincial land-use planning policy and complementary Planning Act changes

The Government is proposing more changes to the Planning Act, and consulting on a new policy document called the Provincial Planning Statement that combines the Provincial Policy Statement, 2020 and A Place to Grow: Growth Plan for the Greater Golden Horseshoe. AMO will be reviewing these proposals in more detail as to how these proposals will impact other housing legislation.

Direct Responses to Municipal Feedback:

- The legislation responds to municipal concerns regarding the municipal requirement to gradually refund zoning by-law and site plan application fees if they failed to make a decision within specified time periods by proposing to postpone the start date to July 1, 2023 to give municipalities time to adjust.
- In response to feedback on smaller projects, the proposal also includes the flexibility for municipalities to use site plan control for residential projects with 10 or fewer units in specific circumstances.
- The proposal also intends to address the concerns of municipalities and others have raised regarding the shortage of building inspectors. AMO looks forward to working with the Government as it redesigns on the qualification program and creates modern tools, quidance, and partnerships with key stakeholders in this area.

AMO will continue to review the proposals and update members, as needed.

City of Toronto Audit Update

On March 29, Toronto City Council adopted the Terms of Reference for the Municipal Bill 23 Audit.

By July 1: Provide an independent estimate of the financial impacts of Bill 23 assuming the City would meet/exceed the new housing targets, over the 10-year period, 2022 to 2031. The engagement will ensure modeling assumptions are supportable, probable, and complete.

By September 30: Evaluate activities and decisions on investments in growth-related infrastructure (since 2018) scoped around 3 principles:

- Accountability Did the City levy and use municipal development-related charges, such as development charges (DCs) and parkland dedication levies, according to their intended purpose consistent with the DC background study, appropriate legislation and having regard for council direction?
- Effective Did the City follow a prudent process to ensure DC funds collected are appropriately applied against DC eligible growth projects included in the DC Background study? Page 19 of 37

3. *Efficient* – Did the City make timely investments in growth-related infrastructure through well-organized project management and administrative processes?

The Minister of Municipal Affairs and Housing had also committed to launch a third-party audit of other select municipalities to get a factual understanding of finances, including reserve funds and DC administration. AMO will continue to follow the progress of the work coming from City of Toronto audit and looks forward to more information regarding other municipal audits as it becomes available.

At the meeting held on April 5, 2023, Council of the Township of Mulmur passed the following resolution in support of Bill 5 – Stopping Harassment and Abuse by Local Leaders Act, 2022

WHEREAS Bill 5—Stopping Harassment and Abuse by Local Leaders Act, 2022 was introduced in the Ontario Legislature by MPP Stephen Blais through a Private Member's Bill on August 10, 2022;

AND WHEREAS the Township of Mulmur and Council are committed to demonstrating good governance and greater accountability to its Code of Conduct and workplace policies;

Whereas municipally elected leaders do not have an appropriate accountability structure when it comes to perpetrating violence and harassment in the workplace; and

Whereas a fundamental, underlying principle of broadening diversity, equity and inclusion in politics rests on the assumption that the workplace is safe; and

Whereas Bill 5, the *Stopping Harassment and Abuse by Local Leaders Act* would require Councillors to comply with the workplace violence and harassment policies of the municipality they represent, permit municipalities to direct the Integrity Commissioner to apply to the court to vacate a member's seat for failing to comply with the municipality's workplace violence and harassment policies as well as restrict officials whose seat has been vacated from seeking immediate subsequent re-election; and

Whereas over 20 municipalities have formally endorsed and communicated public support for Bill 5; and

Whereas Bill 5 would both hold accountable and protect all municipal officials;

An Overview for Bill 5*: The Stopping Harassment and Abuse by Local Leaders Act

The Issue at Hand

Municipally elected leaders do not have an appropriate accountability structure when it comes to perpetrating violence and harassment in the workplace. In fact, if a claim of egregious (the most severe) harassment is substantiated; the maximum penalty that can be imposed is three months without pay. But the councillor can retain their position, return to the workplace and seek re-election.

This differs from any other workplace in the province, where not only are workplaces mandated to have violence and harassment in the workplace policies (Bill 168), these policies outline consequences for egregious violation which includes termination.

Why this Bill is so important

The Bill was introduced as a private members bill, as a response to a sitting councillor in Ottawa who was able to seek re-election, even with outstanding claims of egregious sexual harassment (investigation by the integrity Commissioner was underway). Other instances of councillors perpetrating harassment include Brampton, Barrie and Mississauga. Since this advocacy effort has started, there are further instances cited in many other municipalities across the province of Ontario.

What will the Bill do?

The Bill has three primary components:

- 1. Require councillors to comply with the workplace violence and harassment policies of the municipality they represent.
- 2. Permit municipalities to direct the Integrity Commissioner to apply to the court to vacate a member's seat for failing to comply with the municipality's workplace violence and harassment policies.
- 3. Restrict councillors-whose seat has been vacated-from seeking immediate subsequent re-election.

The Consequences of Doing Nothing

When councillors are able to perpetrate harassment without being held to account, a toxic message is sent to the community.

It means that as an elected official:

- 1. You are immune to the communal standards of treatment we have come to expect from the population at large, and;
- 2. You can abuse your power, unchecked, and continue to have the privilege of serving the population that elected you.

A fundamental, underlying principle of broadening diversity, equity and inclusion in politics rests on the assumption that the workplace is SAFE. This is currently not the case. As such, despite the most recent municipal elections in October, 2022, councillors currently can perpetrate the most egregious acts of harassment and keep their jobs.

This has an immeasurably negative impact on communities.

- 1. Community members and/or municipal staff may not feel safe meeting with their local ward councillor.
- 2. If a person is harassed, they may not see the point of filing a complaint with the Integrity Commissioner-if suitable action cannot be taken
- 3. There is no deterrent for councillors when it comes to perpetrating harassment when they know they can still keep their job.
- 4. It stifles diversity of voice at the local decision making table—when personal safety is at risk, quality people may be detered from seeking election.
- 5. When councillors who have perpetrated harassment to staff or fellow councillors can retain their position, no matter how serious, it creates and protects toxic workplaces, which in turn has an adverse effect on mental health in the workplace and throughout the community.

- 6. Lack of accountability supports current systems of privilege and immunity of a certain segment of the population, which is not optimal for healthy communities.
- 7. It sends the message that if you have power, you are different, and superior to the average citizen.

History of the Bill

Private Members' Bills do not often get passed. They usually deal with an issue of public interest. In this instance, the Bill has received all party support. It was introduced as Bill 260, then the legislature was prorogued when the Federal Election was called. It was then reintroduced as Bill 10, but died when the provincial election was called. It has since been introduced as Bill 5 and it is slated for its second reading in May, 2023. This Bill needs support from every avenue to become law.

The Bill will amend:

- 1. Municipal Act, 2001
- 2. The City of Toronto Act, 2006

Motion Respecting Declarations of Emergency for Homelessness, Mental Health and Opioid Addiction
COM-C 14-2023

Regional Council, at its meeting held on February 23, 2023, passed the following recommendation, as amended, of its Public Health and Social Services Committee:

Whereas Niagara Regional Council acknowledges that the challenges of homelessness, mental health and the opioid crisis are exceptionally complex issues that have a measurable and significantly detrimental impact on the residents of the Niagara region, including the loss of life;

Whereas addressing these issues places extreme stress on upper and lower-tier municipal programs and services, the Niagara Regional Police, Niagara Health, Emergency Medical Services and various non-profit service providers across the region;

Whereas the challenges of homelessness, mental health and opioids have seen a trend of becoming more prevalent in recent years and continue to have a significant impact on the Niagara community;

Whereas Niagara Region, through the staff in Community Services and Public Health, has taken many steps to address these issues with the development and provision of best-practice programming designed to mitigate their impact on the community;

Whereas Niagara Regional Council acknowledges that the challenges of homelessness, mental health and the opioid crisis are intrinsically diverse and should not be viewed as a single monolithic problem;

Whereas addressing these challenges will require strategies and tactics that are specifically designed for each of the unique issues;

Whereas Niagara Region accepts that the responsibility to address these challenges rests with multiple stakeholders, including the provincial government and its agencies;

Whereas 26 Niagara agencies within the Region, including Public Health and Emergency Medical Services, have collaboratively developed a Substance Use Prevention Strategy known as the Opioid Prevention and Education Network of Niagara, and are actively implementing it;

Whereas Niagara Region is a "Built for Zero" community that has accurate and timely data regarding its homeless population and delivers programs and services targeted for strategically helping those individuals experiencing homelessness;

Whereas the challenges of homelessness, mental health and opioid addiction are found throughout the entire province of Ontario and are not unique to Niagara;

Whereas Niagara Regional Council recognizes that municipal emergencies in Ontario are declared by the head of council as per the process detailed in the Emergency Management and Civil Protections Act; and

Whereas Niagara Regional Council acknowledges that the declaration of an emergency does not immediately result in a municipality receiving any additional funds or resources from senior levels of government.

NOW THEREFORE BE IT RESOLVED:

- That the Regional Chair BE DIRECTED to formally issue three separate declarations of emergency, in the areas of homelessness, mental health and opioid addiction, as per the procedure outlined in the Emergency Management and Civil Protection Act;
- 2. That the Regional Chair **BE DIRECTED** to send correspondence to the Provincial Government requesting that action be taken on the eight measures proposed by the Association of Local Public Health Agencies (as previously endorsed by Regional Council on June 23, 2022), including:
 - a. Creation of a multi-sectoral task force to guide the development of a robust provincial opioid response plan that will ensure necessary resourcing, policy change, and health and social system coordination;
 - Expanding access to evidence informed harm reduction programs and practices including lifting the provincial cap of 21 Consumption and Treatment Service (CTS) Sites, funding Urgent Public Health Needs Sites (UPHNS) and scaling up safer supply options;
 - c. Revision of the current CTS model to address the growing trends of opioid poisoning amongst those who are using inhalation methods;
 - d. Expanding access to opioid agonist therapy for opioid use disorder through a range of settings (e.g. mobile outreach, primary care, emergency departments, Rapid Access to Addiction Medicine Clinics), and a variety of medication options;

- e. Providing a long-term financial commitment to create more affordable and supportive housing for people in need, including people with substance use disorders;
- f. Addressing the structural stigma and harms that discriminate against people who use drugs, through provincial support and advocacy to the Federal government to decriminalize personal use and possession of substances and ensure increased investments in health and social services at all levels:
- g. Increasing investments in evidence-informed substance use prevention and mental health promotion initiatives that provide foundational support for the health, safety and well-being of individuals, families, and neighbourhoods, beginning from early childhood; and
- h. Funding additional and dedicated positions for public health to support the critical coordination and leadership of local opioid and substance abuse strategies;
- 3. That the Regional Chair **BE DIRECTED** to send correspondence to the Minister of Municipal Affairs and Housing requesting action be taken to correct the funding allocation model for homelessness based on the results of Auditor General's 2021 report which found that provincial funding in this area is incorrect;

That the Regional Chair **BE DIRECTED** to send correspondence to the Ministry of Health and the CEO of Ontario Health requesting that the province immediately commit to fully funding gaps in mental health service as have been identified in the Needs Based Planning project by Niagara Ontario Health Team's Mental Health and Addictions Working Group, as well as funding ongoing annual increases as required by inflation and population need;
- 5. That the Regional Chair **BE DIRECTED** to send correspondence to Federal Minister of Justice and Attorney General, David Lametti, and Federal Minister of Health, Jean-Yves Duclos, reaffirming Regional Council's October 22, 2020 motion urging the Federal government convene a task force to explore the legal regulation and decriminalization of all drugs in Canada;
