Care and Maintenance Fund

Required under the *Funeral, Burial and Cremation Services Act, 2002* (including Ontario Regulation 30/11) the following below contributions will be remitted to an irrevocable cemetery care and maintenance trust fund. Income from this fund will be used for care and maintenance expenses of the cemetery in perpetuity.

Interment Rights

40% (or minimum \$290) of the purchase price of one in-ground grave (2.23m²/24ft² or larger)

40% (or minimum \$175) of the purchase price of one child or cremation grave (smaller than 2.23m²/24ft²)

15% (or minimum \$165) of the purchase price of one niche (columbarium)

20% (or minimum \$830) of the purchase price of one crypt (mausoleum)

Markers

\$0 for the installation of a flat marker (smaller than 1,116.13cm²/173in²)

\$100 for the installation of a flat marker (1,116.13cm²/173in² or larger)

\$200 for the installation of an upright marker (1.22m/4ft or less in height and 1.22m/4ft or less in length, including the base)

\$400 for the installation of an upright marker (more than 1.22m/4ft or less in height and 1.22m/4ft, including the base)
