PURPOSE

The applicant, the City of Sault Ste. Marie (c/o Planning Division), proposes to amend the Housing Community Improvement Plan (CIP) to allow the term length of a Tax Increment Equivalent Grant (TIEG) to be adjusted to align with other funding sources, while maintaining the same overall grant value. This amendment is intended to provide flexibility to structure the TIEG length to match the term required by other funders. Although the duration of grant payments may change, the total value of the grant would remain unchanged.

PROPOSED CHANGE

The following is proposed to be added to Section 2.5.4 Financial Incentive Program Value:

“The applicant may request that the term length of a TIEG be adjusted to align the grant with other funding sources, while maintaining the same overall grant value. Only the duration of the grant payments would change, while the total value of the grant would remain unchanged. This option is only available where a specific TIEG term length is required by an external funding source.”

If you wish to be notified of the Council of the City of Sault Ste. Marie decision to adopt or refuse the approval of an application, you must make a written request to the Planning Division at the address noted above.

LEGAL NOTICE CONCERNING YOUR RIGHT TO APPEAL

As per the Planning Act, appeal rights are only provided to specified persons, public bodies, applicants, registered owners of any land to which the by-law and/or plan would apply to, the Minister, and the appropriate approval authority.

If a person or public body does not make oral submission at a public meeting or make written submission to the City of Sault Ste. Marie before the By-law is passed, the person or public body may not be entitled to appeal the decision of the Council of the City of Sault Ste. Marie to the Ontario Land Tribunal.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the City of Sault Ste. Marie before the By-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.
